In return for a minimum donation of £30 per Coracle from you to Macmillan Cancer Support we agree to let you borrow one or more Coracles from us on the following terms and conditions:

1. Borrowing of the Coracle(s)

- 1.1. You are allowed to keep the Coracle(s) for the Borrowing Period (usually 2days) and are responsible for it\them including the cost of any repairs required to it\them or replacement of it as a result of your use of it\them during the Borrowing Period.
- 1.2. If, following your use of the Coracle(s), any repairs or replacement are required we will notify you of the cost of repair or replacement in writing which you will be responsible for up to a maximum of £500 per Coracle (which is the full replacement cost of a Coracle).
- 1.3. Please be mindful of where you decide to practice in the coracles, it is potentially possible to practice at the Pengwern Boat Club. However, in order to do so, permission for use and date approval must be obtained in advance directly from the Club by contacting Jayne Chelton at Functions@pengwern-rowing.co.uk.

2. Collection of the Coracle(s)

- 2.1. You will collect the Coracle(s) from the Collection and Return Location at the time specified above on the first day of the Borrowing Period.
- 2.2. If you do not collect the Coracle(s) on time we will attempt to reschedule for a later date but due to limited availability of Coracles we cannot guarantee that alternative dates can be arranged.

3. Return of the Coracle(s)

- 3.1. You will return the Coracle(s) to the Collection and Return Location at the time specified above on the last day of the Borrowing Period.
- 3.2. If you do not return the Coracle(s) on time you will be charged £50 per day per Coracle until all the Coracles are returned up to a maximum charge of £400 per Coracle (which is the full replacement cost of a Coracle).

4. Limitation of Liability

- 4.1. You accept that your borrowing of the Coracle(s) from us is entirely at your own risk. We do not accept any liability for any loss or injury arising from your use of the Coracle(s).
- 4.2. We are in no way excluding or in any way limiting our liability to you for:-
 - a) death or personal injury caused by our negligence;
 - b) fraud or fraudulent misrepresentation; or
 - c) any other liability which cannot be excluded by law.
- 4.3. In letting you borrow the Coracle(s) we are not giving any warranties or other terms, express or implied, including as to quality, fitness for a particular purpose or any other kind whatsoever in respect of the Coracle(s).
